Tim then passed his thanks to PaulW for picking up the pieces following resignations of the Club Secretary & Ride Lead Co-Ord Roles earlier in the year.</p> <p>Also made reference to the excellent ride safety achieved over the last twelve months by all you ride attendees</p> <p>This is to be Tim's last year in this role he explained.</p> |
| 2 | <p>Club Secretary Report:</p> <p>PaulW added his thanks to the attending members, then reflected on a couple of items:</p> <p>Resignations: it was a shame to loose both Luke Danials (secretary) & Kirsty Cocoran (ride leader co-ord') following their great work whilst in office. The decision was made that I take on those roles going forward, the easier option for simplicity sake for the running of the Club until the AGM.</p> <p>Membership: the last year finished with a wonderful 75 members, the current renewals so far this year see's us up to 57 to date with a 44/13 gender split. Another thanks given to all concerned for their continued support.</p> <p>Kit Window: the Autumn Window was taken up by many but the recent Spring Shop window was closed disappointingly with little interest and re-funds arranged with Champion Systems for those that had ordered items. We will be looking to do a 10th Anniversary New Kit design this year.</p> |

Treasures Report.

Stewart Batchelor (SB) presented the accounts for the period of April2023/ March2024. SB was happy to report that the Club is faring well with a closing balance of £1913.62 for this past year, the Expenditure was £1437.52 whilst the Income was £1697.60 in total with a positive £260.08 increase for the past twelve months.

The main expenditures again were for refreshments for our Solstice & Equinox Rides, Champion Systems for our Kit discount & prize vouchers & Website Subscriptions this year. Also explained the Derby Velodrome finances that spanned the last & current years were the cheque payment of £357.92 is yet to be cleared.

Web Admin.

This important role has seen both StewartB and PaulW continuing with this role for us again, this is split in to two parts, the Website (Weebly) and the Forum (Google). No concerns have been recorded.

Ride Coordinator.

PaulW, presented us with the data we had achieved over the past 12 month's cycling like 183 rides with 1416 attendees over some 57,500 miles ridden which was a small reduction on the previous year mainly due to us having 14 cancelled ride days.

The new consolidated Ride Data for the past few years was presented by JamesT which will be viewable with the graphs etc in the forum post with attached AGM presentation. Thereafter there was a long discussion about the proposed French Weekend visit in 2025.

SurveyMonkey Result Data: this is the first time we have tried this fresh approach and Tim presented us with some of the results and pointed out as this was newly completed and the new committee will have much to review. The results presented were in the first instant very good with a NPS (Net Promoter Score) of 52 which is considered to be very good indeed. See the AGM presentation to fully review the explanations and some data.

The Westbury Community Café was our most visited, 23 times, plus Ride Attended data saw Stuart McMahon in the top spot this past year with 65 Club rides in total.

Ride Group Captains (GC) Roles: these have been a great success it was reported over the past year and they JamesT (A), StewartB (B), NiallB (C), GlynnisE/KirstyC (L&Br) & PaulW (MW) were all thanked for their efforts in making this work so well. But can we do this differently going forward was a question asked?
